Briggsville Dam in Clarksburg Coming Down

When in 2006 Cascade Paper Co., the new owners of the former Strong-Hewat woolen mill in the Briggsville section of Clarksburg, discovered they had also acquired liability for the dam beside Rte. 8, they called Trout Unlimited. Good move. TU called Massachusetts Riverways (Department of Fish and Game) and HooRWA. As a result, with a lot of help from friends, the dam will come down late this fall or early this winter.

The dam no longer impounds water, as the area behind it is totally filled with cobbles. The removal will restore habitat in a cold water ecosystem on the North Branch of the Hoosic River. This trout fishery is stocked and also contains wild trout. The North Branch will be free flowing 10

miles from its headwaters at Alpenwald to the dam at Natural Bridge State Park.

Dam inspectors estimated that repairing the 145-footlong, 15-foothigh, 100-year-old dam, used to divert water to cool the

building, would cost \$700,000, which would be borne by Cascade. Estimated cost for removing it is \$400,000, of which Cascade's share will be \$10,000. The rest of money is pledged by project partners TU, Riverways, American Rivers, the US Fish and Wildlife Service, Natural Resources Conservation Service, the Doris Duke Foundation through the Wildlife Conservation Society, and Gillette and National Grid through Massachusetts Corporations Wetlands Restoration Partnership.

The firm of Fuss & O'Neil has completed the final engineering design, as modified by Milone and MacBroom, particularly in relation to protecting an upstream bridge on Cross Road.

The engineers determined that there would be no threat to down-stream structures or habitat from the project. Removal of the dam should alleviate flood threat to the former mill building and adjacent Rte. 8. Construction bids will be advertised in the fall.

Permitting is nearly completed, with the Massachusetts Secretary of Energy and the Environment granting a waiver from a full Environmental Impact Report. The state is monitoring biological life in the river before and after dam removal.

Boaters, Do Your Duty! Keep Zebra Mussels Out!

The state Department of Conservation and Recreation has issued regulations regarding the zebra mussel prevention program, which strives to keep the invasive, non-native mollusk from infesting Massachusetts waters. All boaters - motorized and self-propelled - in the Hoosic and Housatonic river watersheds are required to certify that their boat has not been in any body of water known to contain zebra mussels, or if it has, the boat has been decontaminated according to DCR guidelines. Hoosic River Revival Coalition Has Vision for North Adams

Imagine a downtown North Adams, MA where both branches of the Hoosic River (now largely encased in concrete) are lovely to look at, suitable for water recreation, bordered by trails running through parkland, and where people come for business and socializing.

That is the vision that has motivated a coalition of citizens and public officials, including HooRWA, for more than a year. The coalition, which calls itself

Hoosic River Revival, is exploring the "softening" in various ways of the concrete flood chutes built by the US Army Corps of Engineers (USACE) in the 1950s. Similar efforts have successfully reinvigorated downtown waterways in other cities around the nation.

The coalition has several grant requests outstanding. The next step will be taken this fall by a planning class at Williams College, under the direction of Sarah Gardner. Students will look at a section south of Heritage State Park in North Adams, to try to design ways in which the river, enclosed in flood chutes and berms, could be made more hospi-

table to trout and more attractive to humans. The study will be completed in December.





5th Annual Hoosic River Ride

More than 130 riders showed up for the 5th annual Hoosic River Ride, held August 23, 2009, helping to raise several thousand dollars for HooRWA's research, education, and advocacy programs. Bikers could choose routes of 13, 33, and up to 70 miles in length, variously enjoying the covered bridges and Battle Monument in Bennington, the farmland along the Hoosic in Eagle Bridge, or for the most ambitious – Petersburg Pass on the MA/NY state line.
